Dear Father Studniewski,

On January 11, 2017 you were appointed Administrator of Saint Peter Parish in Washington, D.C. After consultation and in view of your willingness, I am now changing your responsibility to that parish.

For the glory of God and the well being of Christ's holy Church, I appoint you Pastor of Saint Peter Parish in Washington, D.C. for a term of six (6) years, effective immediately. As of today, March 19, 2018, I declare you canonically installed as Pastor with all the rights and responsibilities attached to that office.

In order that you may assume your duties as Pastor, I ask that you present this letter and the accompanying decree to Very Reverend Monsignor Charles E. Pope, V.F., Dean of the Northeast Deanery. Given the fact that you have already served for a year at Saint Peter Parish, it is not necessary to have a ceremonial installation; however, should you choose to have such an installation, please be in contact with Monsignor Pope so that this could take place within a reasonable period of time. Finally, I ask that you make an appointment with the Chancellor of the Archdiocese to take the necessary Profession of Faith and Oath of Fidelity.

As I entrust to your pastoral care this portion of God's people, I ask that in your generosity and zeal you love and serve them. I recognize your willingness to accept this new responsibility and have every confidence that you will continue to provide appropriate pastoral leadership at Saint Peter Parish, Washington, D.C.
